

ORDINANCE NO. 3353

**“AN ORDINANCE CLOSING A PORTION OF THE PLATTED ALLEYWAY BETWEEN STANLEY STREET AND BLAKELY STREET AND BETWEEN 4TH AVENUE AND 6TH AVENUE ADJACENT TO PROPERTIES ADDRESSED AS 409-519 SOUTH STANLEY STREET; 1316 WEST 6TH AVENUE; 410-524 SOUTH BLAKELY STREET; AND 1303-1305 WEST 4TH AVENUE”**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STILLWATER, OKLAHOMA:

A part of Block One (1) WHITEHURST ADDITION, to the City of Stillwater, Payne County, State of Oklahoma, according to the recorded plat thereof, being more particularly described as follows:

Beginning at the Southeast corner (SE/cor) of Lot Twenty-Four (24), Block One (1), WHITEHURST ADDITION; Thence North 00°20'08" West along the east line of Lots Twenty-Four (24) through Thirty-Nine (39), Block (1), inclusive, a distance of 400.00 feet, to the Northeast corner (NE/cor) of Lot Thirty-Nine (39), Block One (1), WHITEHURST ADDITION; Thence North 89°39'58" East, a distance of 20.00 feet, to the Northwest Corner (NW/cor) of Lot Eight (8), Block One (1), WHITEHURST ADDITION; Thence South 00°20'08" East along the west line of Lots Eight (8) through Twenty-Three (23), inclusive, a distance of 400.00 feet, to the Southwest corner (SW/cor) of Lot Twenty-Three (23), Block One (1), WHITEHURST ADDITION;

And a tract beginning at the Southeast corner (SE/cor) of Lot Forty-Four (44), Block One (1), WHITEHURST ADDITION; Thence North 00°20'08" West along the east line of Lots Forty-Four (44) through Forty-six (46), Block (1), inclusive, a distance of 90.00 feet, to the Northeast corner (NE/cor) of Lot Forty-six (46), Block One (1), WHITEHURST ADDITION; Thence North 89°39'58" East, a distance of 10.00 feet, to the center of the platted alley for Block One (1), WHITEHURST ADDITION; Thence South 00°20'08" East along the center of the platted alley for Block One (1), WHITEHURST ADDITION, a distance of 90.00 feet; Thence South 89°35'50" West, a distance of 10.00 feet, to the Point of Beginning.

be and the same is hereby closed to the public. The City reserves the right to reopen the above, pending such time as it may be vacated by the District Court.
