

**ORDINANCE NO. 3340  
(PZ-16-2072)**

“AN ORDINANCE REZONING TRACTS OF LAND LOCATED AT 506, 510, 514 AND 524 SOUTH LINCOLN STREET FROM RTM, TWO-FAMILY AND MULTI-FAMILY RESIDENTIAL DISTRICT, TO O, OFFICE DISTRICT.”

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STILLWATER, OKLAHOMA:

Tract 2: Lot Six (6) and the East Twenty (20) feet of Lot Seven (7), Block Thirteen (13), Hoke's Subdivision of Blocks Thirteen (13) and Fourteen (14), West College Addition to the City of Stillwater, Payne County, Oklahoma, according to the recorded plat thereof, commonly known as 524 S. Lincoln Street, Stillwater, Oklahoma; and

Tract 3: Lot 3, Block 13, Hoke's Subdivision of Blocks Thirteen (13) and Fourteen (14), West College Addition to the City of Stillwater, Payne County, Oklahoma, according to the recorded plat thereof, commonly known as 506 S. Lincoln Street, Stillwater, Oklahoma; and

Tract 4: Lot 4, Block 13, Hoke's Subdivision of Blocks Thirteen (13) and Fourteen (14), West College Addition to the City of Stillwater, Payne County, Oklahoma, according to the recorded plat thereof, commonly known as 510 S. Lincoln Street, Stillwater, Oklahoma.
