1. CALL MEETING TO ORDER.

Vice-Chair calls the meeting to order at 5:30 p.m. and explains the procedures and process for the meeting.

2. PUBLIC HEARING:

- a. Boris Fissioun, Highpoint Group, LLC, MAP AMENDMENT (MA22-11), consideration, discussion, and possible action, including recommending approval or denial of a request to rezone property addressed as 603 W Highpoint Drive, Stillwater, OK, from Commercial Shopping (CS) to Commercial General (CG).

Vice-Chair Allred introduces the items and asks staff to present.

Jacquelyn Porter, City Planner, presents the map amendment and asks if there are any questions for staff. Vice-Chair Allred asks if there are any questions for staff; none respond.

Vice-Chair Allred opens the public hearing and asks if the applicant or representative want to speak.

Boris Fissioun, 1006 S Edgemoor Dr, Stillwater, OK, says that he is here to answer any questions the Commissioners may have.

Commissioner Prather asks why Commercial General (CG) would be better for his location than Commercial Shopping (CS). Mr. Fissioun explains that anyone who has been interested in renting the property would need a specific use permit for their type of business and so far no one has wanted to wait the length of that process. Mr. Fissioun says Commercial General would open it up for more businesses without needing a specific use permit.

Vice-Chair Allred asks if there are any more questions for the applicant; none respond. Vice-Chair Allred asks if there is anyone else who would like to speak in favor; none respond. Vice-Chair Allred asks if there is anyone who would like to speak in opposition; none respond. Vice-Chair Allred closes the public hearing and asks for staff to present the findings and alternatives.

Ms. Porter presents the findings and alternatives.

Vice-Chair Allred asks if there is any discussion or a motion.

Commissioner Shanahan motions to accept the findings and recommend the City Council approve the map amendment (MA22-11) as presented; Commissioner Prather seconds.
