  - B. Provide Additional Construction Inspection for the above project.
  - C. Provide Additional Construction Testing for the above project.
  - D. Provide Additional Grant Administration for the above project.
  - E. Provide Additional Construction Administration for the above project.
  - F. Provide Additional Survey for the above project.
  - G. Provide Additional Geotech for the above project.
  
2. The following fees shall be added to Section V. B. for the services described in Item I of this Amendment:
  - 1A. \$94,300.00
  - 1B. \$60.00 per hour, not to Exceed \$24,000.00 (Estimated at 10 hours per day, 40 additional working days)
  - 1C. Actual Cost Plus a Fixed Fee of \$1,200.00, Not to Exceed \$12,000.00
  - 1D. Please see Attached Fee Schedule, Not to Exceed \$2,000.00
  - 1E. Please see Attached Fee Schedule, Not to Exceed \$6,000.00
  - 1F. \$4,000.00
  - 1G. \$3,500.00
