Chair Noble called the meeting to order at 7:02 p.m.

5. GENERAL ORDERS

- a. Consider adopting transfer policy (SUA-16-23)

Deputy City Manager Dan Blankenship reported that the purpose of a written policy on the transfer of funds from the Stillwater Utilities Authority (SUA) to the General Fund is to guide future Councils and Board of Trustees in their decisions on transfers and provide utility management with the consistency and predictability that is necessary for a stable, well-planned financial operation of the utility. Mr. Blankenship presented a draft of the proposed policy to Trustees and reviewed how the policy would function and defined "surplus funds". Staff recommended approval of the proposed transfer policy formally defining "surplus revenue" and limiting the General Fund transfer to the actual amount of surplus revenue in any given year; transfers would continue to be made on an as needed basis up to the limit; and occasional transfers from the SUA fund balance could be made when needed for specific purposes. Trustees were pleased to receive the proposed policy they had requested. Discussion occurred regarding occasional transfers from the SUA fund balance during a fiscal year. Vice Chair Darlington requested that wording be added to the resolution specifying that occasional transfers during the year be approved by the Trustees. The policy will be brought back before Trustees in the form of a resolution at the next SUA meeting.
