1. CALL MEETING TO ORDER

Chair Noble called the meeting to order at 6:41 p.m.

- g. FY 2017 budget amendment reflecting costs of Electric Administration, Engineering, Distribution Maintenance, and Warehouse for Stillwater Utilities Authority

In response to Trustee Joyce's inquiry as to why the budget amendment was necessary, Acting General Manager Blankenship explained that when the budget was being entered into the new accounting software, the budgets for Electric Administration, Engineering, Distribution Maintenance, and Warehouse for Stillwater Utilities Authority were inadvertently omitted.

- a. Stillwater Energy Center update (SUA-16-29)

Electric Director Loren Smith reported that the construction of the Stillwater Energy Center (SEC) is slightly behind the compressed schedule and remains on budget. The projected cost of the project is \$69,816,395, with approximately \$59,000,000 paid out to date. The project is expected to be completed on or slightly under budget in mid-July. Any remaining project funds will be used for minor projects related to the SEC or to purchase spare parts for the engines and auxiliary equipment. The steam units at Boomer Lake Station will be decommissioned on June 30, 2016.




