

ORDINANCE NO. 3364

**“AN ORDINANCE CLOSING A PORTION OF A GENERAL UTILITY EASEMENT AT PROPERTY ADDRESSED AS 1201 W. 6TH AVENUE”**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STILLWATER, OKLAHOMA:

A tract of land in the Northeast Quarter (NE/ 4) of Section Twenty-Two (22), Township Nineteen (19) North, Range Two (2) East of the Indian Meridian, Payne County, Oklahoma, more particularly described as follows: Starting at the Northwest Corner (NW/COR) of said Northeast quarter (NE/4); Thence, East along the North line of said Northeast Quarter (NE/ 4), a distance of 1349.20 feet; Thence, South a distance of 47 feet; Thence, East parallel to the North line of said Northeast Quarter (NE/4), a distance of 87.10 feet; Thence, East parallel with the North line of said Northeast Quarter (NE/4), a distance of 255.25 feet to the West right-of-way line of Adams Street (vacated), said point being the northeast corner of the General Utility Easement recorded in Book 1569, Pages 932-933; Thence, South 00°26'49" West along said vacated right-of-way a distance of 22.75 feet to the southeast corner of the Permanent Easement recorded in Book 1759, Pages 498-500, said point being the Point of Beginning; Thence, South along the East line of said General Utility Easement, a distance of 69.25 feet; Thence, West perpendicular to the East line of said General Utility Easement a distance of 10.00 feet; Thence, North parallel to the East line of said General Utility Easement a distance of 6.00 feet; Thence, West perpendicular to the East line a distance of 10.00 feet to the West line of said General Utility Easement; Thence, North along the West line of said General Utility Easement a distance of 76.60 feet to a point on the South line of said Permanent Easement; Thence, South 87°08'55" East a distance of 6.04 feet; Thence, South 46°23'34" East, a distance of 19.15 feet to the Point of Beginning. Tract contains 1,496 square feet (0.0343 acres), more or less.
