PURSUANT TO STILLWATER CITY CODE SECTION 10-143 All buildings or structures which are authorized to be moved shall be made to conform with the requirements of the ordinances of the city governing the erection of a new building or structure on the proposed new location.

PURSUANT TO STILLWATER CITY CODE SECTION 10-149 Within thirty (30) days after a building or structure has been removed, the remaining foundation materials and other site development refuse shall be removed, any depression left on the lot shall be filled with clean material, and the lot shall be returned to an open, maintainable state. Erosion control shall be provided and maintained until proper ground cover is established to control erosion. The property owner shall be responsible for compliance with this section.
