

**ELECTRIC RATE**  
**ENERGY EFFICIENT RESIDENTIAL SERVICES (EERS)**  
**Revision 17**

- I. EFFECTIVE IN:** All areas served retail by the Stillwater Electric Utility, hereinafter referred to as SEU, of the Stillwater Utilities Authority.
- II. AVAILABILITY:** *This rate is no longer available to new customers.* The rate will be continued for existing EERS designated customers for the duration of their residence in the homes that had previously qualified for the EERS rate. Once the home changes hands, is rented, or a new party requests service at the address, the billing will revert to the Residential Rate (RS) or another applicable residential rate.
- This rate is not available for resale, standby, breakdown, auxiliary, supplemental, business or manufacturing use.
- Service will be supplied at one location for the entire electrical requirements of the customer and shall be at a nominal secondary voltage of 120/240 volts single phase unless specifically agreed to by SEU.
- Service will be furnished in accordance with SEU Rules, Regulations, and Conditions of Service, and the Rules and Regulations of the City of Stillwater and the Stillwater Utilities Authority.
- III. CUSTOMER CHARGE:** \$9.50 per customer per month.
- IV. ENERGY CHARGE:**

- V. MINIMUM BILL:** The minimum monthly bill shall be the Customer Charge as defined under this Rate Schedule. SEU shall specify a larger minimum monthly bill, calculated in accordance with SEU's Allowable Expenditure Formula in its Terms and Conditions of Service when necessary to justify the investment required to provide service.
- VI. LATE PAYMENT CHARGE:** A late payment charge in an amount equal to ten per cent (10%) of the total amount due on each monthly bill as calculated under this Rate Schedule or \$2,500, whichever is less, will be added if the bill is not paid on or before the due date stated on the bill. The due date shall be twenty-one (21) days after the bill is mailed.

**VII. SAMPLE CALCULATION:**

- SUMMER**
1. Multiply kWh X \$0.10034.
  2. Multiply kWh X PCA.
  3. Total Steps 1 and 2.
  4. Add \$9.50 monthly charge.
  5. Multiply total of Step 4 times applicable tax.
- WINTER**
1. First 600 kWh per month: multiply kWh X \$0.10034.
  2. All additional kWh per month: multiply kWh X \$0.05690.
  3. Multiply total kWh X PCA.
  4. Total Steps 1, 2 and 3.
  5. Add monthly charge of \$9.50.
  6. Multiply total of Step 5 times applicable tax.

**VIII. TERM:** Available only to current EERS customers at their present location of service. Service under this rate will cease when the home is sold, rented, or a different individual applies for service at this address.

**IX. DEFINITIONS:**

- A. Production Cost Adjustment (PCA):** A factor determined by SEU and applied to the cost of energy used by the consumer to account for variations in the cost of generating or purchasing power.
- B. Billing Month:** A period of approximately 30 days extending from the previous meter reading date to the present meter reading date
- C. Summer Season:** The summer season shall include the customer usage months starting on May 1 and ending on September 30.
- D. Winter Season:** The winter season shall be the customer usage months starting on October 1 and ending on April 30.
