Release and Waiver of Liability, Assumption of Risk and Indemnification Agreement

1. I am the owner of the dog(s) identified above.

3. I understand that the act of unleashing my dog(s) at the Stillwater Municipal Pool facility involves risk of physical harm or injury, illness, and/or damage to me, my dog(s), other participants, and other dog(s).

I, on behalf of myself, and my personal representative, heirs, next-of-kin, successors, agents, or any other legal representative or interested parties, hereby fully assume all such risk of loss, damage, injury, and/or illness that may be sustained by myself or others, or my dog(s), resulting from participation in the "Pooches in the Pool" event.
5. I understand and agree that I shall be strictly liable for any damage or injury to other participants or dog(s) or City of Stillwater staff or volunteers caused by me or my dog(s) while participating in said event.

I understand and acknowledge that the City of Stillwater will not have a veterinarian or any person trained in rescue or resuscitation of animals involved in aquatic activities on site at said event and that I am fully responsible for the care and welfare of my dog(s) at all times. I also confirm that my dog has current vaccinations.

By signing this release, I hereby indemnify and hold harmless and fully and forever release and discharge the City of Stillwater, Oklahoma, its officials, employees, agents, and/or volunteers from any claim, demand, cause of action, or suit at law or equity in the present or future, without limitation as to the nature or source thereof, whether the same be known or unknown, anticipated or unanticipated, intentional or negligent, resulting from or arising out of my participation in this event.
8. I agree to abide by the posted rules regarding participation in this event and shall follow the instructions of City of Stillwater employees and/or volunteers in conjunction with said event.
9. I agree to leave the Stillwater Municipal Pool facilities immediately should my dog(s) become aggressive or violent, if I am unable to safely control said dog(s), or if directed to do so by a City of Stillwater employee or volunteer.
